## Dear Exhibitor:

Thank you for your interest in the 2025 Friends School of Minnesota (FSM) Plant Sale. The Garden Fair will be held Thursday, May 8–Sunday May 11, 2025.

This year the Garden Fair will be located just north of the end of Liggett Street, northwest of the Grandstand on the Minnesota State Fairgrounds. The State Fair requires the Friends School Plant Sale parking to move from the Midway (west of the Grandstand) to the Transit Hub (northwest of the Grandstand). We are relocating the Garden Fair to ensure that Garden Fair Exhibitors will continue to be connected with thousands of Minnesotans who are interested in the unique character of our annual event and who support our school's core values of peace, justice, simplicity, integrity, and community. Please note the following:

• Exhibitor sale dates: Thursday, May 8 (optional; 2:30 pm–8:30 pm), Friday, May 9 (9 am–8 pm), Saturday, May 10 (10 am–6 pm), and Sunday, May 11 (10 am–2 pm). The volunteer pre-sale (by invitation only) is on Thursday, May 8 (2:30– 8:30 pm). While you may open for business that afternoon/evening, feedback from Exhibitors is that Garden Fair sales are very small during that period. As a result, many Exhibitors wait to open until Friday morning when the sale opens to the public. You may sell on Thursday, though, if you wish. Each Exhibitor is issued 2 complimentary tickets for the Thursday pre-sale as well as 2 coupons for the discount plant sale on Sunday.

• No unsealed food or beverages may be sold or offered for consumption on site or from Exhibitors' booths without additional permits from the Minnesota State Fair and the State of Minnesota. These applications for offering samples are separate from application for the Garden Fair. More information is available upon request.

• Selection process: Exhibitors in the Garden Fair are chosen from applications reviewed and accepted by the FSM plant sale committee. We seek Exhibitors who provide products or services that do not duplicate those offered by the Friends School of Minnesota. Uniqueness of product can be determined by comparing your stock to offerings in our previous plant sale catalogs. • Submission of an application does not guarantee entry into the Garden Fair. To apply, please send the application along with your registration fee (https://www.friendsschoolplantsale.com/gardenfair-apply) as soon as possible. We will acknowledge your application and deposit your payment if accepted. We will notify you and return your registration fee if you are not selected to participate in the Garden Fair. • Exhibitor check-in and set-up are 10:30 am to 2:00 pm on Thursday, May 8, 2025 at the wristband station located on the West End Plaza just northeast of the Grandstand. Please make alternative arrangements with the on-site Garden Fair coordinator, Huong Nguyen, if you are unable to deliver your product and get it unloaded onto your assigned site during those times.

• **Parking and unloading** space will be unavailable to Exhibitors Thursday May 8th between 2 pm and 8 pm. If you choose to open for sales Thursday, you must be completely set up by 2 pm. Or you may decide to attend the plant sale pre-sale instead, using the 2 complimentary tickets each Exhibitor is given

• All paperwork required for participation in the Garden Fair must be returned to Friends School of Minnesota by Monday February 10, 2025 if you're interested in being listed in the printed catalog. Otherwise, exhibit space needs to be reserved by Friday April 11, 2025 and all paperwork must be returned to Friends School of Minnesota by Monday, May 5th before the start of the sale in order to exhibit at the sale. Your presence in the Garden Fair will be included on the plant sale website.

• **Space assignments** in the Garden Fair are on a first-come, first-served basis for new Exhibitors. You will be notified of the assigned site for your set-up during the week before the sale opens. Due to the changes we are necessarily making for the 2025 sale, we are still considering various configurations for Exhibitors' sites. We will do our best to locate all booths in equally desirable spots based on the total number of Exhibitors and the special needs of some products. We take your requests under consideration, but cannot guarantee particular spaces will be available.

• **Materials**: Exhibitors are responsible for their own signage, tents, tables, and chairs. Nothing can be taped to walls.

• **Payment**: At the close of your final sale day, we will work with you individually to collect FSM's portion of your sales. See application form for specifics. Those who pay before leaving the 2025 Garden Fair pay a smaller percentage of sales than those who must be billed afterwards.
